

## Door-to-Door Solicitation

You must first obtain a business registration to offer goods or services for sale at a private residence.

Solicitation is only allowed during the hours of 10:00 a.m. to 8:00 p.m. from April 1<sup>st</sup> through September 30<sup>th</sup> and 10:00 a.m. to 6:00 p.m. from October 1<sup>st</sup> through March 31<sup>st</sup>. **No solicitation is allowed at any time on Sunday or on a legal state or federal holiday.**

## Hotel/Motel/Airbnb

In addition to a business registration, you must complete a Transient Room Tax Registration form available in the Finance Department. The Fire Department requires you to sign an Affidavit of Installation of Smoke/Carbon Monoxide Alarm(s).

## Felony Background Check

Pursuant to Roseburg Municipal Code Section 9.100.020, a business registration may not be issued to:

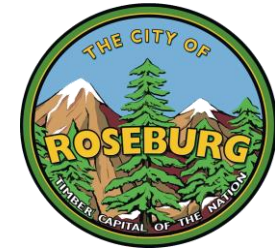
- a. Anyone who has been convicted of a felony within the last 7 years; or
- b. Anyone who has been convicted of a misdemeanor within the last 7 years relating to fraud of theft or any law or statute where the elements of such relate to the business activity to be conducted.

An appeal process option is available.

- ❖ I registered my assumed business name with the State; do I still need a business license in Roseburg?
  - Yes, registering with the state does not give you permission to operate within City limits.
- ❖ Do I need to register my business if I operate it out of my home?
  - Yes, anytime you provide a service, product, or trade within city limits you need to obtain a business license
- ❖ I just purchased a business; can I use the previous owner's business license?
  - No, change of ownership requires a new registration.
- ❖ If I live outside of Roseburg but plan on providing services in city limits, do I still need a business license?
  - Yes, if you are providing a service, product, or trade in city limits you must obtain a business license.

# Business Registration

*Congratulations on your decision to start your business in the City of Roseburg...*

City Administration



Roseburg Municipal Code Section 9.02.020 states, "...no person shall engage in business or be a merchant within the City without first registering with the City Recorder."

## Registration Process

The City of Roseburg requires businesses operating inside the City limits to register with the City and pay a one-time non-refundable \$150.00 fee. Businesses operating out of their home must also complete a "Statement of Compliance for Home Occupations". Business registration applications are reviewed by the Police, Community Development and Fire Department for approval. Upon approval, a business registration certificate will be issued, which must be displayed in public view.

Please note: change of address, additional location(s), or change in ownership are subject to new registration and fee. The addition of a Co-Owner to an existing business registration is subject to a \$75.00 fee.

All vending cart businesses need the following:

- City of Roseburg Business Registration
- Douglas County Environmental Health Department Review

- Inspection of vending cart by Roseburg Fire Marshal  
(541) 492-6770
- If you plan to have a vending cart in the parking lot of a business you need:
  - Permission from business owner of the parking lot
- If you plan to have a vending cart in a park you need:
  - Concessionaire permit from City Parks Division
