

NEW SPEED LIMITS IN SCHOOL ZONES



Senate Bill 179, which was recently passed by the Legislature, will modify the definition of 'School Zone' in order to apply reduced school speed zones during all hours of the day. Speed signs will be changed to "SPEED 20 AT ALL TIMES", if the school zone is 30 MPH or less and adjacent to school grounds. It means that the "Speed Limit 20" applies 24 hours a day, 7 days a week, 365 days a year within these school zones. This change will take effect on July 1, 2004. Currently, City staff is working on checking school zones and installing new signs to meet the effective July date. Please visit www.odot.state.or.us/traffic/ for more details. 

The City of Roseburg is home to Douglas County's first off-leash dog park. Happy Tails Dog Park was opened to the public on June 5, 2004.

The off-leash dog park idea was brought to the Parks Commission by Ms. Deidra Hemmingway and Ms. Christy Cutting in May of last year. They suggested to the Commission that a dog park would be of great value to the residents of Roseburg and the surrounding community. The Parks Commission heard the request and agreed that the idea had merit. However, the Commission also realized that due to budget



unteers to identify a location that would serve public need.

A number of sites were brought forward for discussion. The site that provided the greatest potential was located just south of Templin Beach Boat Launch I. The area was previously cleared of heavy vegetation and seeded with grass. The site provided a location that has adequate parking available, mature trees that would provide a

dant shade, and is in an area that would disturb few neighbors. The Parks Commission visited the site, approved the location and forwarded their recommendation on to the City Council for approval.

In November, the City Council acknowledged the recommendation from the Parks Commission, received public input, approved the Templin Beach Park site for the dog park. Council reminded the dog park advocates that the City would not be required to provide funds towards construction of the park.

The dog park supporters began a fundraising campaign, through numerous public meetings and support from local businesses, were able to raise over \$7,500. These funds were used to purchase fencing, trash containers, benches, doggie bag stations and other amenities. In addition, a metal kiosk housing the rules was constructed as an Eagle Scout project. To help with maintenance, a number of supporters have come forward to volunteer to clean up the park once it was opened.

The park is located off of Templin Avenue and Arizona Street near Templin Beach Park. Park hours are from dawn to dusk. Please contact the Parks Department at 672-7701, extension 236 for further information.

FALSE ALARM C·H·A·N·G·E·S

The Roseburg City Council recently approved a change to the current Roseburg Municipal Code involving false alarms.

"False alarm" by definition means an alarm signal that elicits an urgent response by the police, fire or emergency medical personnel, when in fact, circumstances reasonably justifying such response are found not to exist at the time the alarm signal was transmitted.

Prior to the new ordinance, owners were cited into Municipal Court only after the business received five or more alarms in a 90-day period. This standard of allowing businesses multiple warnings contributed to an ever-increasing demand on emergency response calls for several reasons.

During the past five years the City of Roseburg has experienced a significant amount of growth involving new construction. Most of these new buildings have fire alarm systems installed as part of the life safety for the building. In the past few years, City of Roseburg emergency service personnel have been

reduced due to budget cuts. While fire and police personnel are out of service on false alarms they are unable to respond to actual emergency service calls.

Another significant problem involving false alarms is that prior false alarms and alarm system malfunctions may reduce the positive effect of having an alarm system in the building. This further creates a problem because the occupants may not respond appropriately to the alarm notification. Numerous false alarms reduce the occupants' appropriate responses to the alarm.

Under the new regulations, repeat violators would be issued a fee for the third and each subsequent false alarm during a calendar year. Six or more false alarms would result in a fine not to exceed \$1,500. Intentional violations would be treated as a crime that could carry a \$5,000 fine and up to one year in jail. Two false alarms will be allowed annually without penalty.

Often while the fire department is responding to an alarm they are notified enroute that the alarm is

false. Fire department personnel are still mandated by written policy to respond. This is to determine cause of the alarm.

Recently a high occupancy structure within the city cancelled the fire department while personnel enroute to a reported alarm. Fire department personnel responded and discovered there had actually been a real fire.

Fire Chief Jack Cooley recently noted, "Half of the department's resources are used every time the alarm is a false alarm." Cooley said, "By raising fines, we're doing anything most other cities in Oregon are already doing. The purpose of this ordinance is to hold property owners financially and legally responsible for their alarm systems and discouraging misuse."



TRASHING DOUGLAS COUNTY LESS BY GRASSCYCLING

Want a simple, natural approach to lawn care? Grasscycling is the practice of leaving grass clippings on your lawn. These clippings are mostly water and decompose quickly to release nutrients back into the lawn.

Grasscycling saves time - Don't Bag It!

By grasscycling, you don't have to stop your mower every 10 minutes or so to empty the bag or spend time raking cut grass off your lawn.

Grasscycling provides free fertilizer

Leaving grass clippings on your lawn can generate more than 50 percent of a lawn's fertilizer needs and can reduce the time and money spent fertilizing.

Grass clippings don't cause thatch

Thatch is not made up of grass, but of roots and rhizomes that decompose slowly. But, grass clippings decompose rapidly and help make your lawn more vigorous and durable.

Grasscycling helps keep our rivers and waterways cleaner

By grasscycling, you're helping water quality and saving money. By using less fertilizer and fewer pesticides and herbicides, you reduce pollution of our waterways.

GRASSCYCLING HINTS

- Mow at the right height - Keep your grass to about 2 inches
- Mow lawn when grass is dry to allow better distribution of clippings and less clogging for your mower
- Mow regularly - A basic rule of thumb is to remove only 1/3 of the growth at one time. Prolonged rains sometime make it difficult to mow regularly. In these cases, raise the mower for the initial cutting and then lower it to cut again. Repeat until lawn is desired height. If you only cut once, recycle the clippings into your compost pile.
- Mow with a sharp blade - Dull blades can give the lawn a ragged appearance and increase the potential for disease
- Use a mulch mower, push mower or electric mulching mower - But, any mower in good working condition with a sharp blade can be used to grasscycle. Mulching mowers may be better than traditional mowers if you can't mow on a regular basis. Mulching mowers cut grass into finer pieces, allowing the pieces to filter down among the standing plants.
- Compost/mulch excess grass - If the lawn is too long or wet, use clippings in your compost pile or as mulch.

Recycling is EXPANDING in Roseburg


Roseburg residents can now add a new plastic material to their recycling program and have two new convenient recycling drop-off locations to use.

Plastic film is now accepted for recycling at all disposal site recycle depots and at three Roseburg depots operated by Sunrise Enterprises. (It is not collected as part of curbside collection programs). Plastic film includes a wide array of items;

- plastic grocery bags
- plastic produce bags
- ice bags
- dry cleaner bags
- clean garbage bags (any color)
- shrink wrap
- lumber wrap (found on large bundles of lumber)

The material is generally identified with a # 2 or # 4 inside the recycle arrows and can be clear or colored. (It does not have to have the #2 or #4 to be accepted).

All bag and film material should be clean and empty, with bag ties and staples removed.



This program does **NOT** include:

- hard or rigid plastic of any kind
- bubble wrap or Styrofoam packaging
- tarp material

Plastic bags and film have become more desirable to recycle because of their use in many new products, such as the many brands of recycled plastic/wood lumber. This demonstrates the important connection between buying recycled products and our opportunity to recycle the materials used to make them.

In addition, Sunrise Enterprises has added two convenient recycle depots for public drop-off. The depots are located at 2529 W. Harvard in the Thriftway parking lot and at 2244 NE Stephens next to Ferrellgas and take most, but not all, recyclable materials.

PAVEMENT MANAGEMENT PROGRAM FOR SUMMER OF 2004

As part of the City of Roseburg's Pavement Management Program, twenty streets will get "facelifts" this summer. The Public Works Department has been working closely with the City's pavement consultant to provide the most cost-effective pavement management program possible. The goal of the program is to preserve existing streets within the City efficiently and economically.

The City of Roseburg continues to strive to provide preventative street maintenance. The following streets are expected to be overlaid in an effort to increase the life of the streets. An overlay is the addition of 1½ - 2½" of asphalt over an existing paved surface. The sections of roadway selected are considered based on many factors and are reviewed by the consultant. It is expected that the overlay project will be awarded in the near future with construction to begin late summer or early fall.


The contractor that is awarded the project will be responsible for notifying affected residents 24-48 hours prior to the start of the work. This should be done in the form of door hangars indicating that all vehicles need to be removed from a section of street for a given amount of time. Residents whose streets are affected may be asked to park in their driveways or down the street and walk to their house for one day. Any vehicles on the street will need to be towed to allow for the work to begin. Cooperation in this process is greatly appreciated by everyone involved.

Staff anticipates the final product will be a positive improvement in these neighborhoods. We expect there may be some inconvenience and do appreciate your cooperation during the construction season. AIRPORT FACILITY EXPANSION



The City is in the process of expanding airport facilities at Roseburg Regional Airport, with approximately ninety percent of the project financed with Federal Aviation Administration grant funds. The four-year, \$8 million project is scheduled for completion in November 2005. The City purchased the Town and Country Motel Home Park property and is currently relocating the tenants. This property became the natural location to select for the expansion because of its close proximity to existing facilities. The project will help address safety concerns by relocating the residents that currently reside near airport activity and will provide room to meet the increasing need for hangars. Excavation, utility installation and paving will begin next year and upon completion, the site will be available for the construction of corporate, commercial and t-hangars for the aviation community. The City currently has a waiting list for hangars and will forward to the expansion for pilots in the area and to those visiting Roseburg. For additional information, please call 672-7701.



STEPHENS STREET PAVING PROJECT NOTICE

One of the major Public Works projects planned for this summer is an overlay of Stephens Street, between Gateway Valley Boulevard and the Deer Creek Bridge. The estimated cost for the project will be in the range of \$650,000 to \$875,000, depending on construction options selected.

Most of the construction work is planned to occur at night. It is expected that construction bids will be opened in late August with construction completed no later than September 2004. After the construction contract is awarded, the City will provide an update schedule to area residents and businesses.

MOTORIZED DEVICES IN PUBLIC WAYS

Many citizens have expressed concern regarding the apparent increase in motorized devices on pedestrian ways. The following explanatory information is derived from Oregon State Law:

An electric personal assistive mobility device, (Segway or similar vehicle) is defined as a device that:

1. Is self-balancing on two non-tandem wheels;
2. Is designed to transport one person in a standing position
3. Has an electric propulsion system; and
4. Has a maximum speed of 15 miles per hour.

A motor assisted scooter (or skateboard) is defined by Oregon Statute as a device that:

1. Is designed to be operated on the ground with not more than three wheels;
2. Has handlebars and a foot support or seat for the operator's use

3. Can be propelled by motor or human propulsion; and
 4. Is equipped with a power source that is incapable of propelling the vehicle at a speed of greater than 24 miles per hour on level ground; and
- A. If the power source is a combustion engine, has a piston or rotor displacement of 35 cubic centimeters or less regardless of the number of chambers in the power source; or
- B. If the power source is electric has power output of not more than 1,000 watts.

Operators of either of the above type of vehicles must:

- be at least 16 years of age,
- must wear helmets while operating the device,
- must meet specific lighting and visibility requirements as set forth by statute,
- are exempt from licensing, registration and insurance requirements
- are allowed on sidewalks, bike paths and roadways, (under certain circumstances)

- must always yield to pedestrians on a sidewalk or bike path
- are always limited to speeds not to exceed 15 miles per hour while operating in any public right of way, premises open to the public, sidewalk, bike path, or roadway,
- must not carry passengers, or any cargo that interferes with the safe operation of the device

A motor assisted scooter may not be operated on any street where the speed limit is 25 miles per hour or greater unless it is within a bike lane or crossing the road. The operator must also "walk" across a street in a crosswalk. Parents of kids who allow unsafe or unlawful operation of a motor assisted scooter may be subject to citation and fine.

These rules are covered in more detail in the Oregon Vehicle Code. There are also other specific statutes that cover the operation of these type of devices and can be found in the Oregon Vehicle Code sections 803.030, 803.305, 806.020, 807.020, 811.525, 814.470, 815.230, 815.280, 816.310 816.340 and 822.015.




MAIN STREET & BOOTH AVENUE WATER MAIN INSTALLATION


Installation of 4,500 feet of 16-inch diameter waterline began this spring, with most of the construction work taking place along Main Street and Booth Avenue. The new waterline will provide the feed to a future 1,000,000-gallon tank site at the end of SE Starmer Avenue.

Construction has been complicated due to conflicts with existing utilities, including a major fiber optics line and shallow sewer mains. The new waterline, therefore, had to be installed in the street to avoid existing utilities, creating a bumpy situation for traffic due to trenching for pipe installation. Work is scheduled for completion in mid-August. The City will then have a pavement contractor place an overlay of new asphalt over the entire width and length of the work area on Main Street and Booth Avenue.

INFORMATION FOR PERSONS INTERESTED IN BEING A CANDIDATE FOR MAYOR OR CITY COUNCILOR FOR THE CITY OF ROSEBURG

For the November 2, 2004 General Election in the City of Roseburg, there will be vacancies in the office of Mayor and City Councilor Position Number Two in each of the four wards of the City. To qualify as a candidate for Mayor or City Councilor of the City of Roseburg, you must be:

1. A legal elector under the laws and constitution of the State of Oregon and a registered voter of the City of Roseburg; and
2. A resident of the City of Roseburg for one year immediately before being elected to the office you are seeking. If running for City Councilor, you must also be a resident of the ward you seek to represent when you are nominated and elected, and when you assume office. If you are unfamiliar with the ward boundaries, the City Recorder can assist you. You may not seek candidacy in more than one elective office.


In order for your name to be placed on the ballot as a candidate for City office, you must obtain signatures from a certain number of electors supporting your candidacy. For the office of Mayor, nomination petitions must be signed by at least fifty City electors. For the office of City Councilor, nomination petitions must be signed by at least twenty City electors residing in the same ward in which you live. Nomination petitions must be filed with the City Recorder not less than seventy days before the election. Therefore, the 2004 deadline for filing petitions is Tuesday, August 24, 2004.

To file as a candidate for City office, you must complete the certain election forms and file them with the City Recorder prior to beginning your campaign. The required forms are available in the City Recorder's Office on the 3rd floor of City Hall, 900 SE Douglas in Roseburg. ORDINANCES & RESOLUTIONS

The following are the Ordinances and Resolutions passed by the Roseburg City Council during the last six months of calendar year 2004.

"ORDINANCE": A written directive or act of a governing body. Ordinances have the full effect of law within the local government's boundaries, provided that they do not conflict with a state statute or constitutional provision. An ordinance has two readings at Council prior to being voted on by the Council. An ordinance becomes effective 30 days after the second reading, unless an emergency is declared which enables the Ordinance to become effective immediately.

Ordinance No. 3154: "An Ordinance Declaring the Annexation by Consent of the Property Owners of 15.00 Acres of Land Which May be Described as Township 27 South, Range 06 West, Willamette Meridian, Section 10A, Tax Lot 1400, Known as the Duane Brown Property; Withdrawing Property From Douglas County Fire District 2, and Directing the Filing of a Transcript With the Secretary of State and Amending the Roseburg Comprehensive Plan Map and Concurrent Zone Change for the 15.00 Acre Portion of the Vacant Property Known as the Duane Brown Property Located on the North Side of NW Garden Valley Boulevard," adopted April 26, 2004.

Ordinance No. 3155: "An Ordinance Adding Chapter 4.08 Entitled 'Transportation Systems Development Charge' To Title 4 of the Roseburg Municipal Code," adopted May 10, 2004.

Ordinance No. 3156: "An Ordinance Vacating a Portion of Garden Valley Road Right-of-Way in the City of Roseburg," adopted May 24, 2004.

Ordinance No. 3157: "An Ordinance Amending the Roseburg Comprehensive Plan Map and Concurrent Zone Change for a 0.47 Acre Property Located on the East Side of NE Vine Street Near Its Intersection with NE Oakland," adopted May 24, 2004.

Ordinance No. 3158: "An Ordinance Amending Section 8.02.010 of the Roseburg Municipal Code by Adopting the 2003 Legislative Changes to the State Traffic Laws," adopted May 24, 2004.

Ordinance No. 3159: "An Ordinance Amending Section 7.02.010 of the Roseburg Municipal Code to Update the List of Statutory Offenses Adopted," adopted May 24, 2004.

Ordinance No. 3160: "An Ordinance Amending Section 2.14.040 of the Roseburg Municipal Code and Changing the Organization of the Airport Commission," adopted May 24, 2004.

Ordinance No. 3161: "An Ordinance Repealing Section 7.04.190 of the Roseburg Municipal Code Regarding False Alarms as Nuisances," adopted May 24, 2004.

Ordinance No. 3162: "An Ordinance Adding Chapter 7.08 Entitled, 'False Alarms,' to the Roseburg Municipal Code, adopted May 24, 2004.

"RESOLUTION": An order of a governing body; requires less legal formality than an Ordinance. Statutes or City Charter specify which actions must be by Ordinance and which may be by Resolution. For cities, revenue-raising measures such as taxes, special assessments and service charges are always imposed by Ordinance; fee amendments, however, are made by Resolution. Prior to adoption, a Resolution only needs to be read before the City Council once (by title only, if no member of the Council objects).

Resolution No. 2004-02: "A Resolution Designating Signatures for Bank Accounts," adopted January 12, 2004.

Resolution No. 2004-04: "A Resolution Changing the Boundary of the Roberts Creek Enterprise Zone," adopted January 12, 2004.

Resolution No. 2004-05: "A Resolution Amending Resolution No. 92-13 to Implement a Lien Search Fee," adopted February 9, 2004.

Resolution No. 2004-06: "A Resolution Amending Resolution No. 92-13 Regarding Building Division Fees," adopted February 23, 2004.

Resolution No. 2004-07: "A Resolution Amending Resolution No. 92-13 to Implement New Fees and Amend the Lien Search Fee," adopted February 23, 2004.

Resolution No. 2004-08: "A Resolution Adopting Statements for the City of Roseburg and Goals for 2004-2005."

A minimum of 12 copies should be provided if you are submitting handouts to Council.

Time is set aside for **Public Participation** toward the beginning of each meeting. At this time, anyone wishing to address the City Council concerning an issue of interest not included on the agenda may do so. The person addressing the Council shall, when recognized, give his/her name and address for the record. Remarks shall be directed to the whole City Council. The Council reserves the right to delay any action, if required, until such time when they are fully informed on the matter.
