Operators shall implement and maintain at all times a zero tolerance policy on the use of drugs or alcohol applicable					
to all drivers employed by or affiliated with the company while providing vehicle for hire services. Companies shall provide notice of the zero tolerance policy on their website and/or have it clearly displayed in each vehicle.					

Taxis:

All vehicles operating for a taxi company shall include the company name or logo, phone number and a vehicle identification number in plain sight.

TNCs:

Vehicles operated solely for TNC services shall be clearly marked as operating for the TNC, although any vehicle marking requirements imposed by a TNC may apply.

TNC drivers may not accept street hails, and may only accept rides arranged through the TNC's digital network.

The TNC's software application or website shall display for the passenger the make, model and license plate number of the TNC vehicle.

Written Notice of Compliance from Operator: I have attached a written notice of compliance from the Operator stating I have submitted all necessary documents to meet the terms of Roseburg Municipal Code 9.08. TNC Driver: proof of active status with TNC company (example: screen shot of active account).

By signing and submitting this application, I hereby certify that the foregoing information is true and correct; I have received a copy of Roseburg Municipal Code Chapter 9.08 concerning Vehicle for Hire Service, have read and understand the same and agree to fully comply with all terms and conditions set forth therein.

I understand that I cannot work as a vehicle for hire driver within the City of Roseburg unless I obtain a driver's permit issued by the City of Roseburg.
