CITY OF ROSEBURG AIRPORT COMMISSION MEETING MINUTES March 20, 2025

<u>CALL TO ORDER:</u> Chair Michalek called the meeting of the Roseburg Airport Commission to order at 3:32 p.m., Thursday, March 20, 2025, electronically via Zoom in Roseburg, Oregon.

ROLL CALL:

<u>APPROVAL OF MINUTES</u>: Commissioner Sprague moved to approve the minutes from the February 20, 2025. The motion was seconded by Commissioner Newell and approved with the following vote: Chair Michalek and Commissioners Inman, Paul, Newell, and Sprague voted yes. No one voted no.

DISCUSSION ITEMS:

Taxiway A Extension - Change Order No. 1 - Project No. 22GR18

Herinckx provided a detailed update regarding a proposed change order related to the Taxiway A Extension Project. The change order stems from design revisions required by the FAA, which will increase the overall construction cost of the project.

Herinckx explained that the project design was finalized in April 2024 and submitted to the FAA's Airport District Office (ADO) following their input during the 75% design phase. The project was put out for bid that same month, and revised drawings incorporating earlier FAA comments were resubmitted. In August 2024, City Council awarded the construction contract contingent upon receiving the FAA grant, which was subsequently awarded in September.

However, following staff changes at the ADO, new FAA comments were issued in July 2024 that introduced additional design requirements, separate from the previous feedback. One key revision required reducing the centerline radius of the Taxiway A1 connector from 135 feet to 37 feet, to position aircraft more perpendicularly to the runway, improving visibility down its length.

This modification necessitates significant changes to the design, including the addition of approximately 1,800 cubic yards of fill material and adjustments to the concrete retaining wall that supports the blast fence. Updated plan sheets were submitted to Knife River in

January 2025, and the contractor has since provided pricing for the proposed change order. The FAA has reviewed both the revised plans and the associated cost increase and confirmed that the additional work is eligible for AIP grant funding.

The total amount of the proposed change order is \$219,930.70. Including construction management costs (approximately \$247,000) and other line items, the project's overall financial summary has been updated accordingly. While FAA grants do not cover contingency funds, they can be amended by up to 15% if necessary, pending FAA approval.

The FY 2024-25 Airport Fund adopted budget includes \$2.862 million for capital projects, with an additional \$1.12 million in operating contingency. Approval of this change order will require a City Council action to appropriate funds from the contingency to the capital projects line item.

The updated project funding breakdown includes:

• FAA AIP Grant: \$1,899,846.00

BIL Funds: \$188,113.00

FAA Grant Amendment No. 1: \$197,937.63

City match (Airport Capital Fund): \$79,618.72

This represents approximately \$20,000 more than the previously estimated city match of \$60,000.

Construction is currently scheduled to begin on April 14, 2025. If the Commission recommends approval of Change Order No. 1, the item will be presented to City Council following the March 24th meeting. Approval is needed prior to the start of construction.

Staff recommends that the Commission forward a recommendation to City Council to approve the change order.

Commissioner Paul asked whether the budget adjustment needed to be explicitly included in the Commission's recommendation. Herinckx responded that both the change order and the budget adjustment would be presented together at the upcoming City Council meeting.

Commissioner Newell inquired whether Mead & Hunt had pushed back against the FAA's requested design changes, noting that the original, broader taxiway radius seemed more pilot-friendly. He expressed concern that the revised design, with a sharper turn, offers little practical improvement since the hold short line remains in the same relative location. Herinckx stated that he was unsure and had not asked Mead & Hunt but would follow up. He added that the FAA's rationale was to better align aircraft perpendicular to the hold short line.

Commissioner Newell responded that the revised design still places the aircraft in a similar position, short of the line but still at an angle, and reiterated his belief that the change, while costly, does not appear to offer significant functional benefit. He acknowledged the urgency of the timeline and clarified that his comments were more for inquiry than objection.

Ex-Officio Levin noted that the FAA may have based its decision on comparisons with other airports and that a closer hold short line could raise different concerns.

Commissioner Sprague commented that while the airport does see larger aircraft than average for Roseburg, even larger planes could be utilizing the facility in the future.

MOTION: Commissioner Paul moved to recommend the City Council approve Change Order No. 1 to the Taxiway A Extension project for \$219, 930.70. The motion was seconded by Commissioner Newell and was approved with the following vote: Chair Michalek, Commissioners Inman, Sprague, Newell, and Paul voted yes. No one voted no.

SUBJECT: Airport Fencing and Security Upgrades Bid Award Recommendation – 24GR03

ISSUE STATEMENT AND SUMMARY

The City will receive construction bids for the Airport Fencing and Security Upgrades project. The issue for the Commission is whether to forward a recommendation to the City Council to award the construction contract.

BACKGROUND/ANALYSIS

The airport has been experiencing unauthorized access onto the airfield by people climbing over the fence. Existing portions of the airport perimeter fencing are 5-foot-high chain link without a barbed wire upper section.

This project will replace about 4,800 linear-feet of existing fencing on the east side of the airfield with 6-foot-high chain link fencing and a 3-strand barb wire upper section for a total height of 7-feet. The project will also replace about 550 linear feet of substandard fencing on the west side of the airfield.

In July of this year, staff negotiated Task Order No. 5 to the Master Engineering contract with Mead and Hunt, for design and construction management services for this project.

The project was advertised on July 29, 2025, and the bids will be received on August 19, 2025. Staff will analyze the bids and present the results at the Commission meeting.

FINANCIAL CONSIDERATIONS

The project will be funded using Bipartisan Infrastructure Law (BIL) funds through the FAA's Airport Improvement Program. The FAA grant will cover ninety-five percent (95%) of the total project costs as estimated below. In February, staff received confirmation from the Oregon Department of Aviation that the City's Critical Oregon Airport Relief (COAR) grant was awarded, which will cover up to 90% of the City's match requirement.

Staff will present the construction bids and additional financial information at the Commission meeting.

TIMING ISSUES

The bidding specifications allow for a 45-day bid hold. Staff's intent is to present the Commission's recommendation to City Council at the August 25, 2025 meeting.

Commission options will be presented at the Commission meeting.

SUBJECT: FAA Grant Acceptance

Airport Fencing and Security Upgrades - 24GR03

ISSUE STATEMENT AND SUMMARY

Staff is expecting a Federal Aviation Administration (FAA) grant offer to cover ninety-five percent of the costs for the construction of the Airport Fencing and Security Upgrades project. The issue for the Commission is whether to recommend the City Council authorize acceptance of the grant offer.

BACKGROUND/ANALYSIS

The airport has been experiencing unauthorized access onto the airfield by people climbing over or around the existing fence. Existing portions of the airport perimeter fencing are 5foot-high chain link without a barbed wire upper section.

This project will replace about 4,800 linear feet of existing fencing on the east side of the airfield with 6-foot-high chain link fencing and a 3-strand barbwire upper section for a total height of 7-feet. This section of fence will be located about 15 feet to the east of the existing fence and on property line. The project will also replace about 550 linear feet of substandard fencing on the west side of the airfield adjacent to, and south of gate No. 2.

FINANCIAL CONSIDERATIONS

The project will be funded using Bipartisan Infrastructure Law (BIL) funds through the FAA's Airport Improvement Program. The FAA grant will cover ninety-five percent of the total project costs as estimated below. In February, staff received confirmation from the Oregon Department of Aviation that the City's Critical Oregon Airport Relief (COAR) grant was awarded.

TIMING ISSUES

Environmental work is complete; the project has been designed and bid. Staff anticipates receiving an FAA grant offer in late August or early September. The Commission's recommendation will be presented to City Council at the August 25, 2025 meeting.

COMMISSION OPTIONS

- 1. Recommend the City Council adopt a resolution authorizing acceptance of an FAA grant for the Airport Fencing and Security Upgrades project at the Roseburg Regional Airport, when offered; or
- 2. Request additional information; or
- 3. Not recommend grant acceptance and utilize Airport Funds to pay the costs associated with the project that exceeds the COAR grant funding.

STAFF RECOMMENDATION

Staff recommends the Commission forward a recommendation to the City Council to adopt a resolution authorizing acceptance of an FAA grant for the Airport Fencing and Security Upgrades project.

SUBJECT:

2027-2031 Capital Improvement Plan – FAA AIP and BIL Funding

ISSUE STATEMENT AND SUMMARY

The FAA requested an updated Capital Improvement Plan (CIP) outlining projects planned for both Airport Improvement Program (AIP) funding and Bipartisan Infrastructure Law (BIL) funding. The issue for Commission is whether to recommend approval of the CIP.

BACKGROUND/ANALYSIS

The airport's current approved five-year CIP utilizing AIP funding is shown below:

The chart below outlines the proposed 5-year CIP for federally funded projects at the airport. FY 2025 and 2026 are already programmed and included just for reference purposes.

The projects proposed have previously been discussed and recommended by Commission. The one change that staff is recommending is indicating that Aviation Reserve 2 be identified as the FY 30 and FY 31 projects. In previous editions, the FY 30 project includes Aviation Reserve 1 or 2 as the potential project. By proceeding with Aviation Reserve 2, the excessive fill removed during the runway extension and placed just north of the existing corporate hangars would be regraded and utilized as part of the project. If Aviation Reserve 1 was the next project, the excess fill would remain in place.

FY 2026

Environmental and design work for the Runway and South Apron Rehabilitation project. The 2024 Pavement Condition Index (CPI) for the runway ranged from 62 on the south end to 64 near the middle and 94 for the north 400 feet. The PCI predicts a fair to poor condition during the next 5 to 10 years. The South Apron was reconstructed in 1998. The 2024 PCI was 72 to 74, which is barley in the satisfactory category and is predicted to go to 66 (fair) over the next 5 years.

FY 2027

Construction of the Runway and South Apron Rehabilitation projects.

FY 2028 & FY 2029

Carryover years

FY 2030

Complete environmental and design work for the Aviation Reserve 2 project. This area is located to the west of the north apron area, see attached Airport Layout map.

FY 2031

Construction of the Aviation Reserve 2 project.

FINANCIAL AND/OR RESOURCE CONSIDERATIONS

For FY 25 and 26, both the AIP and BIL grants fund up to ninety-five percent of project costs. For FY's 27 to 31 the AIP and BIL grants will fund up to ninety percent of the project costs. With the projects currently shown, the City's matching requirements would be \$996,989. A portion (up to 90%) of this may be eligible for ODA grants, but those have a maximum amount of \$150,000 per grant. Even with ODA matching funds, the City's match requirements would be just over \$600,000 over the life of this CIP.

TIMING ISSUES

On July 28, 2025, the FAA notified staff the deadline for submitting updated CIPs was September 2. If Commission desires to change the FY 2030 project, that can still happen.

COMMISSION OPTIONS

The Commission has the following options:

- 1. Recommend approval of the five-year CIP as presented; or
- 2. Suggest changes to FY 2030 and 2031 and request staff submit the revised list to the FAA.

STAFF RECOMMENDATION

Staff recommends the Commission recommend approval of the FY 2027-2031 CIP as presented.


