NOTICE OF BUDGET COMMITTEE MEETING AND PUBLIC HEARING  
ON POSSIBLE USES OF STATE REVENUE SHARING FUNDS**

**NOTICE IS HEREBY GIVEN**, pursuant to ORS 294.426, that a public meeting of the City of Roseburg Budget Committee will be held in the Council Chambers of City Hall, 900 SE Douglas Avenue, Roseburg, Oregon on Tuesday, May 6, 2025, at 6:00 p.m. for the purpose of receiving the budget message and receiving comment from the public on the budget for the fiscal year July 1, 2025 to June 30, 2026. The meeting will be livestreamed and accessible from the City's website [www.cityofroseburg.org](http://www.cityofroseburg.org) and live on the City's Facebook page. This is a public meeting where deliberation of the Budget Committee will take place.

In addition, the Roseburg Budget Committee will hold a public hearing on the possible uses of State Revenue Sharing Funds for the Fiscal Year 2025-2026 in accordance with ORS 221.770. During the 2025-2026 budget year, the City will receive approximately \$235,300 in State Revenue Sharing Funds.

Public testimony regarding possible uses for these funds may be provided in person or via Zoom during the meeting, or by submitting written comments addressed to the Budget Officer, City of Roseburg, 900 SE Douglas, Roseburg, Oregon 97470, or by email to [finance@roseburgor.gov](mailto:finance@roseburgor.gov) by 4:00 p.m. on Monday, May 5, 2025. To provide comment via Zoom during the meeting, contact the City Recorder at 541-492-6866 or [info@roseburgor.gov](mailto:info@roseburgor.gov) by 4:00 p.m. on May 2, 2025 to receive a link to the meeting.

Subsequent meetings of the Budget Committee may be held as necessary.

A copy of the budget document may be inspected or obtained on or after April 30, 2025 at City Hall between the hours of 8:00 a.m. and 12:00 p.m. and 1:00 p.m. and 4:30 p.m.
