MINUTES OF THE ROSEBURG CHARTER REVIEW COMMITTEE MEETING August 24, 2022



A meeting of the Charter Review Committee was called to order by Assistant City Manager/Recorder Amy Sowa at 4:00 p.m. on Wednesday, August 24, 2022, 900 SE Douglas Avenue in the City Hall Council Chambers, Roseburg, Oregon.

APPROVAL OF MEETING MINUTES

Member Weller moved to approve the minutes of July 27, 2022. The motion was seconded by Member Baker and approved with the following vote: Members Baker, Cox, Weller and Zielinski voted yes. No one voted no.

CHARTER REVIEW SECTIONS 4 and 5

Ms. Sowa shared that discussion was held regarding Sections 1, 2 and 3 at the July 27. 2022 meeting. The Committee reviewed and made the following proposed amendments for Sections 4 and 5:

Section 4 - City Manager

- Section 4.1:
 - Keep indefinite term for City Manager who shall serve at the pleasure of Council
 - Suggested using the LOC model language regarding residency.
 - Two-thirds vote by Council to remove City Manager.
 - o Remove language regarding a Councilor or Mayor being appointed as City Manager.
- Section 4.2: Keep the current language except for the term "disabled" and change it to "unable to perform duties."
- Section 4.3: Change subsection (e) to say, "Organize, disband or re-organize departments," to add the "re" in front of the second organize.
 - o Recommended adding a new 4.3(e) Delegate duties, but remain responsible for all subordinates, and to use the LOC model language for that section.
- Section 4.4: No changes.
- Section 4.5: Use the LOC Model Section 8.1.
- Section 4.6: After review by Attorney Forrester and Ms. Sowa, it was suggested for removal.

Section 5 – Municipal Court

Section 5.1: Remove "original and" in the sentence, "The municipal court has original and jurisdiction over all offenses."

In response to Member Baker, Attorney Forrester confirmed the City adopts State Statutes for offenses.

- Section 5.2(1): Attorney Forrester and Ms. Sowa recommended removing this section.
- Section 5.2(c): Use LOC language to change language from "accused of an offense against the City," to "Commit to jail or admit to bail anyone accused of a city offense."
- Section 5.2(g): Suggested adding to this subsection "issue search warrants" rather than adding a new area.
- Section 5.3: Attorney Forrester will review language regarding the appointment of a municipal judge and pro-tem judges.

In regards to pro-tem judges, Member Cox said Council needed to be able to express authority over the Court System and Judge. If the Judge was absent, Council needed to know who presided in their place.

Section 5.4: Keep the current language except for the term "disabled" and change it to "unable to perform duties."
