CALL TO ORDER: The meeting of the City of Roseburg Public Works Commission was called to order at 3:30 p.m. Thursday, August 14, 2025, in the Third Floor Conference Room at City Hall, Roseburg, Oregon.

ROLL CALL: Present: Commissioners Ken Hoffine, Tim Swenson, Fred Dayton, Pat Lewandowski, and Brad Johnson

Absent: Chair Ellen Porter, Commissioners John Seward and Stuart Liebowitz

Attending Staff: City Manager Nikki Messenger, City Engineer Daryn Anderson, Civil Engineers Jesten Brenner and Audrey Bowers, Special Projects Coordinator Jennifer Bragg, and Public Works Department Technician Chanelle Rogers

APPROVAL OF MINUTES: Commissioner Lewandowski moved to approve the minutes of the July 10, 2025, Public Works Commission meeting. Motion was seconded by Commissioner Swenson and approved with the following vote: Commissioners Dayton, Lewandowski, Hoffine, Swenson, and Johnson voted yes. No one voted no.

DISCUSSION ITEMS:

Equipment Purchase – Tow-Behind leaf Pickup Machine: Anderson informed the Street Maintenance department is responsible for keeping our streets and storm pipes clean and functioning. Each year, the street maintenance crews removed about 1,000 cubic yards of leaves from city streets. The annual leaf collection program minimizes the amount of leaves entering city storm pipes or plugging storm catch basins and inlets. The current leaf pickup machine is a 2010 and has 3,250 hours of run time on the engine. The City can purchase the same machine through the Sourcewall cooperative purchasing agreement for \$129,888.04 which is four percent discount from the MSRP of \$135,048.04. This piece of equipment is due to be replaced and has funds budgeted in the FY 25-26 Equipment Replacement Fund. Commissioner Lewandowski questioned what the capacity of the leaf machine was. Anderson replied that it is towed behind a 5yd dump truck that the leaves are shot into the back of. Commissioner Dayton asked what the useful life of the equipment was. Anderson said the engine was over the useful life and the machine itself takes a beating from gravel and sticks that are sometimes in the piles of leaves, staff have done a lot of repairs on it over the years to keep it running. Commissioner Johnson stated he was surprised we hadn't replaced it already and wondered if we needed a bigger one or if this size was sufficient. Messenger stated some of the streets it has to go down are tight so this size is sufficient.

MOTION: Commissioner Swenson moved to recommend the City Council authorize the purchase of a XtremeVac LCT6000 tow-behind leaf pickup machine from Old Dominion Brush Company through the Sourcewall cooperative purchasing agreement for \$129,888.04. Motion was seconded by Commissioner Johnson and approved with the following vote: Commissioners Dayton, Lewandowski, Hoffine, Swenson, and Johnson voted yes. No one voted no

INFORMATIONAL ITEMS:

Project Updates: Anderson went over the project update list that was provided in the packet.

BUSINESS FROM THE COMMISSION: Commissioner Lewandowski questioned if Douglas County issuing an Emergency Drought Order would affect the City of Roseburg water system. Anderson replied at this time staff have not seen anything alarming at the Water Treatment Plant that would warrant a water curtailment for citizens served by city water. Discussion ensued.

Commissioner Swenson read his letter of resignation from the Public Works Commission.

SUBJECT: **Award Recommendation – Engineering Design Contract
Douglas Avenue Safe Routes to School**

ISSUE STATEMENT AND SUMMARY

Century West Engineering was previously contracted to design roadway and infrastructure improvements for Douglas Avenue from Rifle Range Street to Patterson Street. Staff is requesting an additional design contract from Century West Engineering for the design to encompass additional design elements needed to satisfy the Safe Routes to School (SRTS) funding requirements. The issue for the Commission is whether to forward a recommendation to City Council to authorize the engineering design contract.

BACKGROUND/ANALYSIS

There are two contracts that precede the work described in this design contract. The first contract was signed in April 2019, and it authorized i.e. engineering for the survey work and Century West Engineering for the preliminary design work for submitted for a SRTS grant. The scope included roadway improvements on Douglas Avenue from Rifle Range Street to Patterson Street. This contract was for design only up to the 75% completion milestone.

The second contract was to bring the design up to the 100% completion point. To provide continuity, the design work was offered to Century West Engineering and the contract was signed in August 2020. This phase of work included designing water, stormwater, and utility facilities as well as sub-surface explorations and a rapid flash crossing device. These plans did not go out to bid for construction.

The design contract being discussed in this memo is to provide engineering design to include provisions to satisfy the SRTS funding package that was awarded to the City. These provisions include adding curb and driveway ramp improvements along Rifle Range Road, between Douglas Avenue and Highway 138, curb ramp improvements for the intersection of Rifle Range Road and Highway 138, and other minor updates as needed to reflect current conditions. The design contract will also include road section design completion from Rifle Range Street west to the Deer Creek Bridge.

FINANCIAL CONSIDERATIONS

The FY 25-26 Urban Renewal Fund includes \$100,000 for the for the design phase of the project. The SRTS grant that was awarded to the City for the construction of this project totals \$2,750,000.

The provided design fees are shown below. At this time the contingency task is assumed to be unnecessary.

TIMING ISSUES

If the Commission provides a recommendation to authorize the engineering design contract, it will be presented to the City Council at their December 8, 2025 meeting.

The project has 5 years to complete construction after the grant award date; or May 2030. These construction tasks for the project are planned to be completed in 2028, after the Douglas Ave Deer Creek Bridge replacement project is complete.

COMMISSION OPTIONS

The Public Works Commission has the following options:

- a. Recommend the City Council award the Engineering Design Contract to Century West Engineering for \$98,980.00; **or**
- b. Request additional information; **or**
- c. Recommend that the City Council not move forward with the project at this time.

STAFF RECOMMENDATION

Staff recommends that the Commission forward a recommendation to the City Council to authorize the Engineering Design Contract with Century West Engineering.

SUGGESTED MOTION

I move to recommend the City Council authorize the Engineering Design Contract with Century West Engineering for an amount not to exceed \$98,890.00
