# CITY OF ROSEBURG PUBLIC WORKS COMMISSION MEETING MARCH 13, 2025 MINUTES

<u>CALL TO ORDER</u>: The meeting of the City of Roseburg Public Works Commission was called to order at 3:31 p.m. Thursday, March 13, 2025 in the City Hall Council Chambers, Roseburg, Oregon.

ROLL CALL: Present: Chair Ellen Porter, Commissioners John Seward, Ken Hoffine, Fred Dayton, Pat Lewandowski, and Brad Johnson

Absent: Commissioners Tim Swenson and Stuart Liebowitz

#### Others Present:

Attending Staff: Public Works Director Ryan Herinckx, Civil Engineers Daryn Anderson, Jesten Brenner, and Public Works Department Technician Chanelle Rogers

<u>APPROVAL OF MINUTES</u>: Commissioner Seward moved to approve the minutes of the February 13, 2025 Public Works Commission meeting. Motion was seconded by Commissioner Johnson and approved with the following vote: Chair Porter, Commissioners Seward, Hoffine, Dayton, Lewandowski, and Johnson voted yes. No one voted no.

Chair Porter introduced the new commission member Brad Johnson and had him give a little information about himself.

#### **DISCUSSION ITEMS:**

Award Recommendation – Task Order No. 1 for Design through Bidding Services for the 24-Inch Transmission Main from Newton Creek Drive to NE Emerald Drive: Anderson informed on February 24, 2025 the City council awarded a master engineering contract to Consor North America for the Five-Year Water Transmission Main Replacement Program. The issue for the Commission is whether to recommend to City Council the authorization of a task order for design through bidding services for Phase 4 of the project. Anderson stated Phase 4 will replace pipe from NE Newton Creek Drive to approximately NE Emerald Drive, then Phase 5 will continue to NE Garden Valley Boulevard. Each task order under the master contract is individually negotiated, based on an agreed upon scope of work. Task Order No. 1 has been negotiated and includes design and bidding services for Phase 4 at a cost not to exceed \$344,907.00. Chair Porter questioned if there were any matching funds. Anderson replied that there were not any for this phase. Commissioner Seward stated the price seemed high. Herinckx said the City has used the company for this project in the past, so staff did some comparisons on the previous phases and material costs and wages have increased over the years. Discussion ensued regarding Phase 5.

**MOTION:** Commissioner Dayton moved to recommend to the City Council authorize a task order with Consor North America for design and bidding services for the 24-Inch Transmission Main from NE Newton Creek Drive to NE Emerald Drive for an amount not to exceed \$344,907.00. Motion was seconded by Commissioner Lewandowski and approved with the following vote: Chair Porter, Commissioners Seward, Hoffine, Dayton, Lewandowski, and Johnson voted yes. No one voted no.

## **AUDIENCE PARTICIPATION:** None

**INFORMATIONAL ITEMS:** Staff provided verbal updates on multiple projects. Herinckx informed every four or five years the city water system and fire department is audited by the Insurance Service Office and they put a rating on the fire protection readiness. The most recent audit was done in the fall of 2024. Herinckx stated there are many factors that are looked at during the audit. The water system scored a 39.83 out of a 40 score. This score put the City in a Class 2 ranking which helps the citizens with homeowners insurance. Herinckx also mentioned the commission meeting can be held in the 3<sup>rd</sup> floor conference room and still be live on Facebook. Some of the commission members would prefer the conference room as it is little less formal than the Council Chambers, others were neutral on location of future meetings.

BUSINESS FROM THE COMMISSION: Commissioner Lewandowski questioned how the generator at the Water Treatment Plant was working. Herinckx said it was used a few weeks prior for about six hours and ran just fine. Commissioner Lewandowski also inquired if the downtown parking is something that the Public Work Commission would be involved in. Herinckx replied that it is not something that the Public Works Commission handles.

**Bid Award Recommendation - 24PW10** 

#### ISSUE STATEMENT AND SUMMARY

The City received bids for the Harvard Avenue Storm – Ballf to Umpqua Project. The issue for the Commission is whether to forward a recommendation to the City Council to award the construction contract.

#### **BACKGROUND/ANALYSIS**

This project consists of replacing approximately 300 LF of new 12-inch storm sewer pipe, 1,050 LF of new 30-inch storm sewer pipe, 4 new storm sewer manholes, 6 new concrete storm inlets, and two new accessible concrete ramps on Harvard Avenue. The 2011 Roseburg Storm Water Master Plan identifies the area west of I-5 and east of Keady Court as being a problem area where the storm system is under capacity. In 2013, i.e. Engineering Inc. created a hydraulic model of this area which was followed up by a study providing recommended phases and upgrades. One of the recommendations was to replace undersized storm sewer pipe on Harvard Avenue between Ballf Street and Umpqua Street. Previously completed projects resulting from this study include the Ballf Street upgrades in 2014, and Harrison Street upgrades in 2021.

Due to their familiarity with the storm system in this area, staff negotiated directly with i.e. Engineering, Inc. to provide civil design services to develop construction drawings and bid documents for this project. The construction bid documents were advertised for bid on May 16, 2025 and bids were opened on June 4, 2025.

Two bids were received and are summarized below:

#### FINANCIAL CONSIDERATIONS

The FY 25-26 Storm Drainage Fund budget includes \$580,000 for this project.

#### **TIMING ISSUES**

The City has 45 days from bid opening to accept or reject all bids. If the Commission recommends award, the bid results will be presented to City Council at the June 23, 2025 meeting. If awarded, the Notice to Proceed would be issued in July. The contractor is allowed 70 calendar days to complete the project.

#### **COMMISSION OPTIONS**

The Public Works Commission can provide its recommendation to the City Council to:

- a. Recommend the City Council award the contract to the lowest responsible bidder, Black Pearl Paving & Excavation; or
- b. Request additional information; or
- c. Recommend that the City Council reject all bids.

#### STAFF RECOMMENDATION

The lowest bidder submitted all required documentation and is considered responsive and responsible. Funds have been budgeted for this project. Therefore, staff recommends awarding the project to the lowest responsible bidder, Black Pearl Paving & Excavation, for \$484,427.00.

#### SUGGESTED MOTION

I move to recommend the City Council to award the Harvard Avenue Storm Improvements – Ballf to Umpqua Project to the low bidder, Black Pearl Paving & Excavation, for \$484,427.00.

#### **ISSUE STATEMENT AND SUMMARY**

The City received bids for the 2025 Garden Valley Boulevard & Stewart Parkway Pavement and Curb Ramp Improvement Project. The issue for the Commission is whether to forward a recommendation to the City Council to award the construction contract.

#### **BACKGROUND/ANALYSIS**

The City of Roseburg refers to the Pavement Management Plan (PMP) to determine which sections of roadways within the City require maintenance or improvements and how to best use City funds. The design of this project was recommended in the PMP. The project improvements include grinding and repaving approximately 800 lineal feet of Garden Valley and 2050 linear feet of Stewart Parkway.

In addition to the street improvements, 25 sidewalk curb ramps will require upgrades to meet current Americans with Disabilities (ADA) standards.

The construction bid documents were advertised on May 13, 2025 and bids were opened on June 3, 2025.

Four bids were received as shown below.

#### **TIMING ISSUES**

The City has 45 days from bid opening to accept or reject all bids. If the Commission recommends award, the results will be presented to the City Council at their June 23, 2025 meeting. If awarded, the Notice to Proceed would be issued in July. The Contract states that a Construction period of 90 days is provided to complete the work.

#### **COMMISSION OPTIONS**

The Public Works Commission has the following options:

- 1. Recommend the City Council award the construction contract to Guido Construction for \$1,450,963.30; or
- 2. Request additional information; or
- 3. Recommend that the Board and Council reject all bids.

#### STAFF RECOMMENDATION

Funds have been budgeted and are available to construct the project. The low bidder submitted all required documentation and appears to be responsive and responsible. The Engineering Consultant is recommending that the project be awarded to the low bidder, Guido Construction Inc. Staff concurs with this recommendation.

#### SUGGESTED MOTION

I move to recommend to award the construction contract for the Garden Valley Boulevard & Stewart Parkway Pavement and Curb Ramp Improvement Project to the lowest responsible bidder, Guido Construction Inc. for \$1,450,963.30.

On June 3<sup>rd</sup>, 2025, four (4) bids were received to construct the above referenced project. Guido Construction, Inc. submitted the apparent low bid for \$1,449,506.10 which is 13% lower than the Engineer's estimate of \$1,663,311.00.

The bid form was properly signed and executed, and the bid submission included a Bid Bond, 1<sup>st</sup> Tier Subcontractor List, a Drug Testing Program Certification Form, Pay Equity Compliance Training Certification Form, a Public Works Bond Pre-Bid Notice & Certification Form, and a Pay Equity Compliance Training Certification Form.

Based upon our review of the bid, Century West Engineering recommends that the City of Roseburg award the construction contract to:

This recommendation is pending final approval of the Public Works Commission, City Council and successful submittal of all required documents identified in the Contract Forms.

**Bid Award Recommendation - 25PW02** 



#### ISSUE STATEMENT AND SUMMARY

The City received bids for the Pavement Management 2025 Slurry Seals project on May 29, 2025. The issue for the Commission is whether to forward a recommendation to the City Council to award the construction contract.

#### **BACKGRGOUND/ANALYSIS**

A slurry seal is a very thin layer of aggregate with an asphalt emulsifier applied to an existing pavement. Slurry seals are used primarily as preventative maintenance to prolong the life of the paved surface.

The construction bid documents were advertised for bid on May 15, 2025 and bids were opened on May 29, 2025.

Three bids were received and are summarized below:

Schedule A of this project consists of 17 street segments at various locations totaling approximately 37.500 square yards. Schedule B of this project consists of slurry seal coating and striping of the Gaddis Park parking lot, Schedule B work is funded from the Facilities Improvement Fund.

#### FINANCIAL CONSIDERATIONS

The FY 25-26 Transportation Fund Materials & Services budget includes \$250,000 for road maintenance projects. The FY 25-26 Facilities Improvement Fund includes \$55,000 for the Schedule B work at Gaddis Park.

Total project costs are estimated below.

#### **TIMING ISSUES**

The City has 45 days from bid opening to accept or reject all bids. If the Commission recommends award, the bid results will be presented to the City Council at their June 23, 2025 meeting. If awarded the Notice to Proceed (NTP) would be issued in July. The contractor is allowed 60 calendar days to complete the project.

#### **COMMISSION OPTIONS**

The Public Works Commission can provide its recommendation to the City Council to:

- 1. Award the contract to the lowest responsive bidder, Doolittle Construction, LLC for \$207,000.00; or
- 2. Request additional information; or
- 3. Reject all bids.

#### STAFF RECOMMENDATION

The lowest bidder submitted all required documentation and is considered both responsive and responsible. Funds have been budgeted for this project. Therefore, staff recommends awarding the project to the lowest responsible bidder, Doolittle Construction, LLC for \$207,000.00.

I move to recommend the City Council award the Pavement Management 2025 Slurry Seals Project to the lowest responsible bidder, Doolittle Construction, LLC for \$207,000.00.
